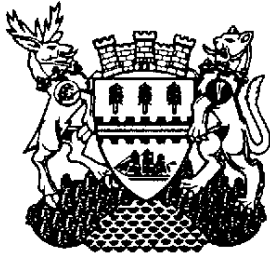

Bird-Friendly Windows

4.2 Presentation: Environmental Coordinator

Staff gave a presentation regarding bird-window collisions and fatalities, noting the following:

- there has been a significant population decline in a number of bird species in Canada, including shorebirds, grassland birds, aerial insectivores, and common forest birds;
- single-family homes account for 90% of building-related, direct bird mortalities, with low-rise buildings (less than 12-storeys) accounting for just under 10%;
- birds do not understand windows and architectural cues as they did not evolve with them, and younglings may be more susceptible;
- solutions include: increasing visibility of glass by applying visual markers such as grid patterns, fritted glass, Acopian BirdSavers, or art; using architectural features to reduce glass surfaces; ensuring that landscaping is adjacent to glass; and reducing light pollution;
- some municipalities have incorporated bird-friendly practices in their design and development guidelines;
- Port Moody addresses the issue in a few ways: embedding bird-friendly design policies in the Official Community Plan (OCP); evaluating new developments through the Sustainability Report Card; and updating the Environmentally-Sensitive Areas (ESA) Development Permit Guidelines.

In response to questions from the Committee, staff noted the following:

- consideration of retrofitting windows at civic facilities would involve training staff to monitor and collect survey data for collisions, including looking for evidence of collisions such as window marks, blood, and carcasses; and
- the current staff priority is research and monitoring;

- there is a potential to do outreach work during Bird Week by providing information and education.

EPC20/006

Invasive Species Update

4.3 Sustainability and Energy Specialist

Staff gave a presentation on the Invasive Plant Management Program, noting the following:

- there are key guiding principles for this program but no official strategy;
- the work is mostly implemented by Parks staff; contractors are required for more specific work, and volunteers also contribute;
- prioritization and formalization of removal work is based on a preliminary inventory of invasive plants and establishment of criteria;
- staff are responsive to important information provided by the community;
- work plans for different invasive species are undertaken by season;
- after invasive species are removed, the area is restored and replanted with native species;
- opportunistic removal is also done while other work is being undertaken;
- giant hogweed is a top removal priority; other invasive species include English ivy, Himalayan blackberry, orange hogweed, spartina, and various species of knotweed;
- staff are provided with training and education to prevent the spread of invasive species and pests;
- staff work with neighbouring municipalities and regional partners to identify locations where invasive species need to be removed;
- there is currently a challenge with knotweed on SD43 properties; and
- the 2020 departmental work plan is proposed to include a dedicated invasive removal crew, with a proposed new service which combines invasive removal and restoration work.

In response to questions from the Committee, staff noted the following:

- there has been some success in knotweed removal from CP Rail land; however, follow-up remains a challenge as the sites have to be continuously monitored after removal and restoration work;
- TransLink has done some of their own invasive removal work as well; and

- climate change is a factor in increasing the spread of invasive species, which are more hearty and resilient, and spread much more efficiently than native plant species.

Port Moody Nature Event Updates

4.4 Staff provided an update on upcoming nature events in the City, including the following:

- Feb. 29, 2020 – The Pollinators film screening, with a panel discussion focusing on pollinators in Port Moody;
- March 8, 2020 – Invasive Plant and Pull at Rocky Point Park;
- March 25, 2020 – Bear Essentials at Inlet Theatre with event time to be determined;
- Earth Week events, including Cigarette Butt Blitz, Bear Essentials, Bats at Night, Community Pollinator Planting at Pioneer Park, and the Enchanted Forest shadow art show.
