Port Moody Police Department Presentation

6.1 Presentation: Constable Vincent Traietti

Constable Vincent Traietti gave a presentation entitled “PMPD Traffic Unit” and referred to slides contained in the on-table package.

Constable Traietti answered questions regarding the following topics:

- the common sources of drunk driving tickets;
- collaborating with Transit Police to manage distracted driving; and
- opportunities for civilians to work with the Port Moody Police Department to help mitigate traffic issues.

ICBC Presentation

6.2 Presentation: Kathleen Nadalin, ICBC Road Safety Coordinator

Kathleen Nadalin, ICBC Road Safety Coordinator, gave a presentation entitled “ICBC Road Safety and Community Engagement” and referred to slides contained in the on-table package.

The Committee noted that heavy penalization regarding excessive speeding is an effective way to enforce road safety.

Kathleen Nadalin answered questions regarding access to intersection safety camera footage, the role of the ICBC Senior Community Relations Advisor, and the potential for implementing graduated driver’s training for motorcycle licenses or supercars.

6.3 Presentation: Engineering Technologist

Staff gave a presentation entitled “loco Road and Murray Street Traffic Signal Modification” and referred to slides contained in the on-table package.

The Committee discussed the proposed intersection changes, noting that:

- overall it is a positive design;
- the islands in the intersection require accessibility improvements, as they are difficult to access using a wheelchair; and
- cars driving in the bus lane should be addressed.

Staff answered questions regarding the following topics:

- the potential for a designated left-turn lane into Moody Middle School;
- the train-crossing signal system;
- adding intersection safety cameras to the loco/Murray intersection; and
- the potential for traffic and safety improvement measures at the loco/loco intersection.

Staff Updates

7.1 Staff provided the following updates:

- the construction of the St. Johns Street multi-use pathway is underway and is scheduled to be complete in February 2024;
- relocating two bus stops along the south section of St. Johns Street is being explored, as they are currently an inadequate distance apart;
- staff will be reporting back to Council on the cumulative transportation model;
- developer provided amenities in lieu of meeting parking requirements is being explored; and
- implementing pay parking models is being further pursued by the City.
